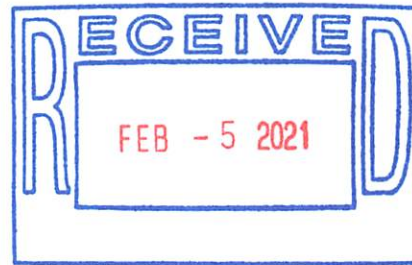


Dear Abby,

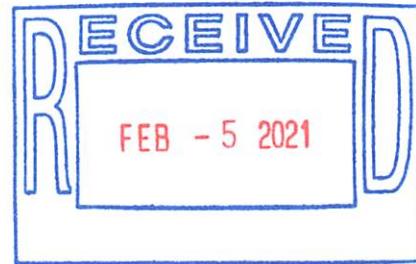
I am support of this project. I actually think it fits well into the sight and believe it will bring now just housing but renewed activity in Lakeville. Business owners will be glad once it is up and going.

The building would be on town water and sewer and would not impact the water quality of the lake or Factory Pond.

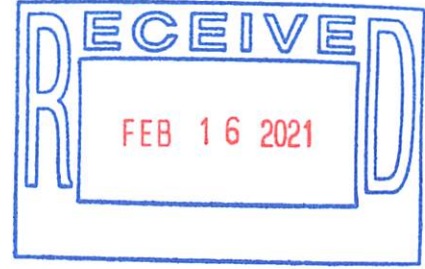
