The Board of Selectmen Meeting minutes of December 6, 2021.

Present: Curtis Rand, First Selectman; Chris Williams, Selectman; Donald Mayland, Selectman; Emily Egan, Secretary; members of the press and public.

The meeting was called to order at 5:00pm.

- C. Williams made a motion to approve the agenda. D. Mayland seconded, and the motion was approved unanimously.
- C. Williams made a motion to **approve the minutes of the November 1, 2021** regular meeting. D. Mayland seconded, and the motion was approved unanimously.

First Selectman Report

The Selectmen thanked Jon Higgins (Planning & Zoning Commission), Bill Willis (Board of Finance) and Steve Victory (ZBA) for their decades of volunteer service on the listed boards.

The Selectmen discussed the Train/Railroad Station Depot building and C. Rand mentioned that he has spoken with the State Historic Preservation Office and as a municipality we would be eligible for state funding to restore elements of the building. The Selectmen discussed the multiple proposals that have been submitted for the building in Lakeville and unanimously decided that all planning should be pursued once the current neighborhood projects that are underway or proposed have been addressed and that at this time only maintenance to the building will be pursued.
