The Board of Selectmen Regular Meeting minutes of November 7, 2022.

#### First Selectman Report

- C. Rand gave a brief update on the status of the Salmon Kill bridge, which will remain closed throughout the winter. The deck has been removed and they are working on the abutments to stabilize the bridge deck which will be reset in the spring.

- C. Rand mentioned that the Pope Land Design Committee has been working with ToDesign with conceptual plans for the property.
