The Salisbury Republican Town Committee strongly supports the plan recently submitted by the Salisbury Housing Committee (SHC) for the Dresser Woods Affordable Housing project on East Railroad Street.

The need for affordable housing in Salisbury is well-known. Fourteen years ago, at a Town Meeting, the Salisbury Affordable Housing Commission (SAHC) was created and charged with a plan for creating more affordable housing in our community. Since then, the SAHC has issued two Affordable Housing Plans, the first in May 2018 and a second in July 2023. The East Railroad Street property was one of the four locations listed in each Plan that is capable of hosting more than two or three housing units.

The 2018 Plan called for the construction of 14 to 18 units at the East Railroad Street site while the 2023 Plan called for 18 to 20 units. We are delighted to see that the plan now before this Commission calls for 20 units, spread over nine buildings. With more than 100 families now on a wait list for affordable housing, maximizing the number of units at this site (and all the sites) is vitally important.

The Salisbury Housing Committee is to be congratulated for putting together a careful and impressive plan for this site, from the Site Plan to the Architectural drawings, the Traffic study and the Storm Water report. We have every confidence that the PZC will carefully review all elements of the plan and give due consideration to any criticisms raised by members of the

community. We would point out, however, that any plan for affordable housing will always draw criticism, which usually begins with "We believe strongly in the need for affordable housing, but . . . ."

As a town, we are blessed to have generous people like the Dresser family, who donated this 5+ acre site to the town for use as an affordable housing site. And we are blessed to have conscientious members of the SHC who have devoted countless hours of their time to hiring and overseeing the entities who have contributed various pieces of the plan. It is important that we respect the judgment and recommendations of those who have done the hard work on these projects.

Dear Chairman Klemens et al,

I wish to make known my firm support of the Salisbury Housing Committee (SHC) plan for the Dresser Woods Project on East Railroad Street as outlined in the Town's 2023 Affordable Housing Plan.

The critical needs for affordable housing in our community have been well documented and do not need to be repeated here. However, I would like to note a few of the reasons why I believe the Dresser Woods project makes good sense and merits the community's strong support.

### **Dresser Woods Makes Sense**

The backlog of people waiting for affordable housing is long – some 100+ applicants are currently on a wait list.

Affordable housing projects need to be located within town borders where access to existing infrastructure such as water and sewers is available. The challenge is to find parcels suitable for affordable housing that are large enough to build more than one or two units to meet the critical demand we have.

The Dresser Woods site is ideal. It is of significant size, 5.3 acres, located close to the center of Salisbury.

Only about half the site will have housing [9 dwellings with 20 affordable rental apartment in them]. The other half will remain conserved as wetlands and open space.

## **Evolution of the Dresser Woods Plans - Well Done!**

First of all, the town did not have to use its own funds to purchase the land. Jim Dresser and his family generously *donated* the desirable 5.3 acre parcel to our town with the proviso it be used for affordable housing.

The SHC assembled a team of top-notch experts (engineers, scientists, architects and others), who studied the site, traffic implications and other aspects of the land and building such a potential project in order to come up with creative solutions with those issues in mind.

The SHC communicated well with the community throughout the development of the plan.

It offered information sessions, on-site visits and other opportunities for the public to learn about the plans and to ask questions. In addition, the Salisbury Affordable Housing Commission partnered with the Salisbury Association last fall to mount a comprehensive exhibit about affordable housing in our community. The exhibit included plans and a rendering of Dresser Woods.

SHC also reached out to neighbors and sought their feedback as well as that of the community. I believe the SHC responded with sensitivity by offering real and constructive solutions.

A rendering of Dresser Woods shows the degree of care and thoughtful consideration that was given the design of this project which fits with the character of our town and region. Landscaping plans will further snug the dwellings in and add a extra measure of privacy and beauty.

I also appreciate the collaboration of the town and all the Salisbury Affordable Housing groups and think it is an exemplary display of how a community can effectively work together to solve problems that will benefit all. That especially includes the work of town personnel, commissions and committees, like P & Z, whose members work diligently year in and year out on projects large and small.

## I support the plan for Dresser Woods.

## **Note of Warning**

IF we fail to take charge and act on plans for Dresser Woods and other affordable housing projects outlined in the 2023 Plan, you can be sure the state or federal government one day WILL. And, no one should be under any illusion that "affordable housing" under state or federal control would be done with a modicum of the thoughtful care and consideration the SHC has put into the Dresser Woods.

I am writing to express my total support for the Dresser Woods Housing Project.

It is easy to imagine that life is bucolic for everyone here in Salisbury. But that has not been the case for a long time, and particularly not since Covid. For some families and residents of this town, life is a real financial struggle. For some, it proves too much. It speaks exceptionally poorly of us as a community, both in terms of our values and our common sense, that we have allowed this situation to continue for so long.

Aside from the very first resident of Salisbury, there has always been someone who could have complained of a view marred, some disturbance caused, some peace potentially shattered, some danger presented in the siting and construction of ALL our houses. We have all brought change upon our neighbors and like them or not, we have all adjusted so we still consider this a wonderful place to live.

To say we should find a 'better' site is ignorant at best. Dresser Woods would sit on donated land with access to town water and sewer, within walking distance to town. There are no more boxes to tick to make this 'perfect.' Sites with these advantages, which make affordable housing development a viable possibility, are as rare as hen's teeth.
