Please remove the Drifting concession for the Lime Rock Race Track. That some people (mostly from outside our area) should have their fun at the expense of the health and safety of town residents isn't a concession; it's an outrage.

My husband and I do not see the need to rehearse the pollution effects of the race practice of Drifting, for we are confident you know about them. Our argument is simple: It would be one thing if the Lyme Race Track were indoors or in an isolated area. It's another thing when it's nestled into a residential area. To permit this level of pollution at this particular race track is to deeply privilege race car fans over the rest of us who are already compromised on racetrack weekends by the sound and, equally challenging, the parade of speeding drivers who treat our town roads as extensions of their racetrack. We say this as residents of Wells Hill Road, for on every race track weekend we already witness multiple cars driving at shocking speeds (the speed limit on our road, in case you aren't aware, is 35 miles per hour; we see cars easily driving twice that speed and faster).

We urge you to do the right thing and for the sake of the residents of Salisbury, ban Drifting at Lyme Rock Racetrack. Lyme Rock Racetrack is a business, and naturally enough it wants to maximize profits. That said, our Town can exercise limits on what they do. This is a case that demands we do that.
