Dear Neighbors and Abutters,

I am an elderly person, long retired, living alone in a house with several bedrooms, a living room, a drawing room, and a doctor's office. I have few visitors. I'd prefer smaller digs, and my barn, a post-and-beam structure as old as the house, could be the answer, only needing insulation, electricity, plumbing, and windows to meet my needs. I would make the footprint smaller by tearing down storage sheds. No trees would be cut down. Downstairs would be a furnace/laundry room, a sleeping room, and, at the west end, a breakfast and living room. Upstairs, looking west, might be a large room with a grand view. It would also require a big investment in insulation and windows and construction time. It will probably remain just a thought.
